## Context

The Master's Thesis is a monographic research project where students are required to show the skills (knowledge and abilities) acquired throughout their master's programme. It is worth 9 ECTS and is carried out at the end of the formative period (second semester). Although the Master's Thesis may be about any area studied on the programme, the learning aims established for the Master's Thesis are global and are intended for students to demonstrate:

- \* Their decision-making ability and critical thinking
- \* Their ability to analyse and summarise information
- \* Their knowledge and understanding of the basic aspects of tourism research
- \* Effective oral and written communication

## Requirements

### Essential

The Master's Thesis may only be presented after having registered on and passing the other subjects required to attain the Master's degree.

## Content

The Master's Thesis course consists of three different modules:

- 1. Introduction to research seminars
- 2. Proposal elaboration
- 3. Elaboration and defense of the Master's Thesis

Students will receive detailed information about all these modules as well as all the necessary steps to complete and submit their Master's Thesis in a meeting that will take place at the begining of the second semester. Additionally, all the information about the Master's Thesis including deadlines, procedures, forms, etc. will be published in the Aula Digital elearning platform.

### Range of topics

Module 1. Introduction to research seminars

Knowledge on how to produce a research paper is necessary in order to deliver the Master's Thesis. For this reason, students will be required to attend different seminars lasting four hours (with an attendance register), as well as to go through some online materials, in order to learn basic research skills. The aim of this module is to teach students how to formulate research

questions and understand necessary criteria to produce a research paper. The contents of these seminars cover:

- \* Selecting a topic
- \* Exploring the literature
- \* Writing a research proposal
- \* Writing a research paper
- \* Citations and references
- \* Writing an abstract

Module 2. Proposal elaboration

The Master's Thesis coordinator shall post the list of tutors and their availability on the Aula Digital platform. Students must look into the suggested topics to make their selection and, if they have any doubts, they may request a meeting with the Master's Thesis coordinator and/ or any potential tutor for guidance. Students must confirm their preference for their project topic over the Aula Digital platform. The Master's Thesis coordinator will be responsible for assigning tutors based on student preferences. Students and lecturers shall be notified about tutor and topic assignment over the Aula Digital platform.

After revising and working with the material of the introduction to research seminars, the student has to design and write a research proposal on one of the Master's topics. Students shall produce their proposal according to the structure, instructions and recommendations given in the seminars. The proposal shall be presented over the Aula Digital platform and, as a minimum, include the following aspects: project title, academic tutor, project motivation and objectives, methodology (model and/or data to use), expected results, work plan and schedule.

Dr. José Luis Groizard shall assess all proposals to see which ones are suitable and which are not. If the Master's Thesis proposal is deemed NOT suitable, students shall have 15 days to improve their proposal in line with the instructions from Dr. Groizard. If the revised proposal delivered after these two weeks fails to meet the basic requirements of a research proposal, the proposal shall be deemed NOT suitable and, therefore, students may NOT proceed to write their Master's Thesis in the current academic year. Proposals that are deemed suitable shall be valid for two academic years, the current one in which they are put forward and the following one, as long as neither the project topic nor tutor change.

Once the proposal has been accepted, students are required to register the Master's Thesis through the on-line platform of the Center for Postgraduate Studies. Detailed information about registration deadlines and procedures will be published in the Aula Digital platform.

Module 3. Elaboration and defense of the Master's Thesis

Before printing this document, please consider whether or not it is necessary. We all share the environment.

Once the student has obtained a positive evaluation of his/her research proposal, he/she will be required to work on the Master's Thesis following the planning included in the proposal and the instructions of his/her tutor.

Students are encouraged to submit and defend their Master's Thesis in July. In justified cases, it will be possible to extend the deadline until September. An extraordinary deadline will open in January only for those students who started their Master's Thesis on previous academic years. All the information about these deadlines will be published in Aula Digital.

All students shall hand in their project in .pdf format over the Aula Digital and Center for Postgraduate Studies platforms with the template provided by the Master's Thesis coordinator that includes the official UIB cover page and complies with the structure set out for the project.

The defence of the Master's Thesis shall be public and it comprises an oral presentation by the student with the duration of 20 minutes followed by a round of questions from the three

members of the Master's Thesis Committee. After this, the committee shall meet privately and propose the mark. The event shall end with notification of the final mark to the student.

If the committee assessing the Master's Thesis deems the project to have very serious faults, it may be returned to the student before the defence. Students may correct the errors detected in the Master's Thesis and hand it in again at the Centre for Postgraduate Studies within the established deadline.

The seminars lasting four hours (with an attendance register) aim to teach the skills of research in the context of the practical problems that new researchers face. To this end seminars combine case studies of relevant research, summaries of key skills and exercises.	4
ECTS tutorials	Work with the supervisor	Small group (P)	Students must work with the supervisor to whom they should show their work periodically. Following this, the supervisor can guide students in their research.	4

#### Defence of the Master's Thesis

Description	Once the supervisor has authorized the student to submit the Master's Thesis, it will be publicly defended in front of an assessment committee.
Assessment criteria	Students shall hand in their project in .pdf format over the Aula Digital and Center for Postgraduate Studies platforms with the template provided by the Master's Thesis coordinator that includes the official UIB cover page and complies with the structure set out for the project. Before submitting his/her work, the student must obtain the authorization from his/her tutor.
	The defence of the Master's Thesis shall be public and it comprises an oral presentation by the student with the duration of 20 minutes followed by a round of questions from the three members of the assessment committee. After this, the committee shall meet privately and propose the mark. The event shall end with notification of the final mark to the student.
	The Master's Thesis assessment shall be carried out from a global perspective, taking into account the literature review, which methodology has been deemed the most suitable and why, which practical proposals have emerged from the research, and what the concluding thoughts and critique have been regarding the entire framework. In turn, the assessment shall also take into account formal aspects (order, structure, writing and bibliography) and the oral and public defence of the project (communication skills, use of time, use of new technologies, etc.). In order to set the Master's Thesis mark, members of the committee shall use the evaluation form and the grading grid provided by the Master's Thesis coordinator which will be published in the Aula Digital platform.
	If the committee assessing the Master's Thesis deems the project to have very serious faults, it may be returned to the student before the defence. Students may correct the errors detected in the Master's Thesis and hand it in again at the Centre for Postgraduate Studies within the established deadline.
	In line with the UIB's commitment to transparency and quality, all of the master's theses presented to complete this degree will be screened through the plagiarism detection tool Turnitin and subsequently stored in its repository. The resulting report will be made available to the members of the board examining the master's thesis, so that they can corroborate its originality.
