## Context

This subject aims at providing students with:

- 1. A good understanding of the systems established at the international level for the protection of human rights, which includes the main international conventions in this area, as well as their control mechanisms (judicial and non-judicial). The focus will be on the universal mechanisms established at the UN level and on the systems established at the regional level: mainly at the European, Inter-American and African level.
- 2. A good knowledge of a number of specific substantive rights or issues, such as the right to life, non-discrimination on the ground of race, gender, sexual orientation etc., the right to food, housing etc., as well as the specific protection afforded to certain groups such as minorities, indigenous people, asylum-seekers, migrants, victims of trafficking etc.
- 3. The ability to apply the acquired knowledge to concrete situations: in a number of practical classes, the professor and students in small groups will discuss and resolve concrete cases.

The professor will share with students her 10 years experience in the UN, including in the Office of the High Commissioner for Human Rights. This course uses both a theoretical and a practical-participatory teaching method: the latter consists in learning through analysis and discussion of relevant case-law, case studies, debates, as well as writing an essay (individually or in small groups) on a specific topic to be chosen by students, which will be followed by an oral presentation. This methodology aims at allowing students to develop both a solid theoretical knowledge and the capacity to examine human rights issues practically and critically, both orally and in writing.

### Essential

1. Having passed "International Public Law"

2. Good command of English, written and spoken (min. B1 level): students should do the "Language level test for subjects taught in English" which is available on the intranet (enter "Campus Extens", go to "Informació dels Estudis de Grau en Dret" where you will find the test under "Informació útil"). We recommend that you do not enroll in the subject if you don't pass the test (except if you take concrete action to improve your English during the first semester in order to be able to pass the test before the start of the second semester).

### Skills

## Specific

- \* International law sources. Students will learn to recognize and find legal texts, reports, judgments and other documentation of an international character, through the databases available on the websites of the major international organizations that have a human rights protection system, such as the United Nations, the Council of Europe and the Organization of American States.
- \* Understanding and analysis of legal texts international conventions, resolutions, reports of international organizations: understand, systematize and interpret legal texts of an international character
- \* Understanding and analysis of international human rights case law judgments and statements from international courts and quasi-judicial bodies: learn to understand the structure and reasoning in judgments and other pronouncements issued by international bodies and tribunals and get a general overview of the main trends in the case-law of these human rights bodies on the most debated and relevant topics

### Generic

- \* Oral communication, through participation in class, in debates and through delivering a short oral presentation of the essay
- \* Criticism. Being able to analyze and contrast legal texts and documents as well as the political, social and other consequences of a decision of a legal character

### Content

At the beginning of the course a detailed program of the course will be provided.

### Range of topics

1. International human rights law and protection mechanisms at the universal and regional level
This first part will introduce students to the systems established at the international level for the
protection of human rights, which include the main international conventions in this area, as
well as their implementation mechanisms (judicial and non-judicial). The focus will be on the
universal mechanisms established at the UN level and on the systems established at the regional
level: mainly at the European, Inter-American and African level.

2. Substantive human rights law: evolution and current debates on fundamental topics

Substantive human rights law will be analyzed based on the main international treaties, main pronouncements by judicial, casi-judicial and non judicial bodies, and the main soft law instruments. It will include:

- the right to non-discrimination (based on race, gender, sexual orientation ...);
- civil and political rights (right to life, arbitrary detention, torture ...);
- economic, social and cultural rights (right to housing, education, health ...);
- collective rights (right to self-determination, rights of indigenous people ...);
- the protection to be afforded to particularly vulnerable groups (minorities, asylum-seekers, migrants, victims of trafficking ...)
- 3. Practical classes and oral presentations

These classes will focus on developing student's ability to apply the acquired knowledge in concrete situations: in a number of practical classes, students will work on the resolution of practical cases. Moreover, students will deliver a short oral presentation of their essay.

## Teaching methodology

This is a "Campus Extens 50" subject, which means that it has a lower number of face-to-face classes and therefore requires more distance work by students in order to study the subject of each class, prepare the essay and the oral presentation and study for the final exam. In order to facilitate the distance work, the teacher provides students with a virtual space (the Campus Extens subject page) in which she will post study and consultation material: this includes the program, PowerPoint presentations used during the course, links to conventions, resolutions and other documents, hyperlinks to websites of relevant international organizations, tribunals and bodies, articles on topics of interest, photos and other multimedia materials. The Campus Extens subject page will also be used for certain evaluation activities, including self-evaluation tests, and students can use it to communicate electronically with the professor through the individualized tutorials forum.

These classes will allow students to exercise their ability to apply their knowledge to practical situations. In one of these practical classes, the professor will also show students how to research a human rights topic: where to find information? how to use a number of international human rights databases? what is relevant in order to be included in an essay? how should a human rights essay be structured and what should be the main sources?	6

## Specific risks and protective measures

The learning activities of this course do not entail specific health or safety risks for the students and therefore no special protective measures are needed.

## Student learning assessment

- The assessment activities will consist of an essay to be prepared individually or in small groups and handed-in online in the Campus Extens subject page (30% of the final mark), an oral presentation of the essay (10% of the final mark) and participation in theoretical and practical classes as well as debates that follow all presentations (10% of the final mark), and a written exam (50% of the final mark).
- For each of these activities, the professor will assess whether the legal concepts have been rightly understood, applied and exposed, also taking into consideration the quality of the written or oral presentation (proper legal reasoning, order, clarity and concision). Evaluation will also be based on the number and quality of references made to relevant international legal texts, judicial and non-judicial pronouncements, reports etc., and the ability to relate these to a specific case/context and reach conclusions on that basis.
- Should a work be copied, the Academic Regulation shall apply and qualification will be reduced between 50 and 100%. Recidivism involves a "0" in the final mark for the course. Is considered fraud, with the same consequences, the fact of using as their own texts of others, taken from reports, other students works or from the Internet (please read the document: "Google: how to use it and not to use it in the Law degree "). The professor will use the Turnitin tool which automatically detects when a text is copied from any text published on paper or in the internet.
- If a student can not perform an assessment activity for an extremely serious and fully unpredictable cause (see the causes provided for in the Academic Regulation) he or she should inform the teacher as soon as possible, to assess the feasibility of alternative solutions.
- In case of not passing the subject, the written examination and the essay are retrievable in the special session (in July), while the oral presentation and the participation in class are not retrievable.

Final grade percentage: 30%with a minimum grade of 3.5
