Context

Public Law of Tourism is one of a set of subjects that allow the reality of tourism to be analysed from a legal perspective, which essentially deals with the intervention of the administration in the provision of tourist services.

Thus it covers areas ranging from the sources of law to the distribution of competences (accommodation, mediation, transportation of travellers, etc.), as well as the accreditation of compliance with the legal requirements throughout the time the tourist activity is provided.

In contrast, the subject does not analyse the civil or commercial relations among the different tour operators or the employment regime applied within them or any behaviours that may be considered a misdemeanour or offence.

Teaching methodology

Students will learn about the Public Law of Tourism by means of theory classes and practical classes. In the first case, the lecturer will give a masterclass to explain the contents of the subject to the students, while in the practical classes students must find a solution to situations involving disputes that should be settled by applying the regulations.

At the beginning of the semester a schedule of the subject will be made available to students through the UIBdigital platform. The schedule will include at least the dates when the continuous assessment tests will be conducted and the hand-in dates for the assignments. In addition, the lecturer will inform students as to whether the subject work plan will be carried out through the schedule or through another way included in the Campus Extens platform.

Specific risks and protective measures

The learning activities of this course do not entail specific health or safety risks for the students and therefore no special protective measures are needed.

Student learning assessment

Students will be evaluated in this subject by means of a system of continuous assessment, which means that they will be assessed throughout the whole semester.

If students pass the tasks or exercises programmed during the course, when it finishes (28th May) they will have passed the subject. The tasks or exercises are as follows:

- Tasks that evaluate the acquisition of theory contents: The theory contents are assessed by means of oral tests, at the end of each of the four thematic blocks, which evaluate only the material in the corresponding block. Consequently, students who pass the four tests will not have to sit the final exam. Students are considered to have passed the tests when their average mark in the four tests is 5 or above. However, since this activity can be retaken, students who do not manage to obtain an average mark of 5 or above will be able to retake the blocks in which their mark was below 5 by sitting the final test. This final test will consist in giving brief answers to a series of oral questions and students will only be able to take the part of the exam corresponding to the block they need to resit. The final mark will be the average of the marks obtained in each block, either in the mid-term tests or in the final exam. In all the tests each question will be graded independently from the others. No negative marks will be given for any of the questions.
- Tests to assess practical skills: The practical part is assessed by presenting practical cases that are carried out individually. They may be oral or written. This activity cannot be retaken.
